Please kindly note that as of 25 May 2018, Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data, hereinafter referred to as "GDPR", which regulates the principles of the processing of your personal data by POL-KRES EDWOOD Daniel Tomaszuk, ul. 
